#### MATURE CONTENT BOOK PROTOCOL STATEMENT CURRICULUM COMMITTEE MEETING 2/15/22

The curriculum committee has considered and edited this statement. The statement is to be read at the next board meeting by Michael Mader, Vice President and curriculum committee member.

For the purposes of this statement the Lower Township Elementary School Board of Education will hereafter be referred to as "The Board" and the Lower Township Elementary School District will hereafter be referred to as "The District."

#### Statement:

The Board is issuing this statement in response to community concerns regarding books containing mature content or language that may be in the Social Issues unit of study or identified as Young Adult reads. It is the sincere hope of The Board that this statement will clarify both the accessibility and the use of the titles in question as well as The Board's actions regarding these books.

The Board became aware of the issues surrounding the book "Black and White" at the May 2021 board of education meeting. Since that time, board members, staff members and administrators have worked toward an acceptable solution to the concerns surrounding the inclusion of the book in the school setting. Ultimately The Board received and considered information from multiple sources before making a decision regarding the title mentioned above as well as all other books identified as young adult or as containing more mature content or language. The information considered came from classroom teachers, media specialists, administrators, the family of the affected student, a book challenge review committee, the curriculum committee and individual board members. Board actions are determined by policy so the district policy on public complaints and grievances was also a part of the decision making process. The following protocols are currently in place.

The decision to read any one of the identified titles lies with the parents. After parental permission has been granted, the teacher can present the book as a possible reading selection and the student can decide if it's

something he/she wants to read. The books are not readily available to students and may only be accessed by the teacher. Students reading any of the titles are typically in book clubs so they would be discussing the content/themes with their book club members with the teacher facilitating the discussion. The teacher will suggest a book be considered only if he/she believes the content matches the social emotional maturity of the student and that the student may have an interest in the themes presented in the book. If a student chooses a book in the media center labeled "YA" the media specialist will give the book to the classroom teacher who is then required to get parental permission to enable the student to read the book.

It is important to note that the specific book in question, "Black and White" is not and never has been a part of the curriculum and is not required reading. "Black and White" is a classroom library book and has always been in sixth grade classrooms. This book as well as any other titles of more mature content are still in their respective settings but with the aforementioned strict protocols.

The Board acknowledges that mistakes were made regarding the accessibility of the book and agrees that it was most unfortunate this book was read without parental permission. The Board will not offer any excuses and moving forward we hope that the multiple steps and safeguards that have been put into place will prevent any future incidents from occurring.

The Board recognizes that parental involvement is important to the success of the school district and by working together and keeping an open line of communication we can ensure that the Lower Township Elementary School District meets the needs of all of our children.
